AWARDED WITH REGISTRATION CERTIFICATE
FOR DOOR-SHAPED ANCHOR BY
THE NATIONAL MEDICAL PRODUCTS ADMINISTRATION**

This is a voluntary announcement made by Beijing Chunlizhengda Medical Instruments Co., Ltd.* (the “**Company**”, together with its subsidiaries, collectively as the “**Group**”), aiming to providing the shareholders of the Company and prospective investors with the latest development about the business operation of the Group.

The board of directors of the Company (the “**Board**”) is pleased to announce that the Company has recently received the registration certificate for “door-shaped anchor” (門型釘) approved by the National Medical Products Administration of the PRC. Door-shaped anchor products are suitable for the fixation of knee and hand tendon tenacity and bone, and are made of cast cobalt-chromium-molybdenum alloy materials that meet the YY0117.03-2005 standard. YY0117.3-2005 standard for casting of casing implants, orthopedic joint prosthesis and cobalt-chromium-molybdenum alloy casting, which is applicable to the industry standard for the production and acceptance of cobalt-chromium-molybdenum alloy casting of orthopedic joint prosthesis. The award of the registration certificate for door-shaped anchor indicates that the Company has made further progress in the field of sports medicine.

Door-shaped anchors are made with cobalt-chromium-molybdenum alloy, which has the advantages of good fatigue resistance and high tensile strength. Therefore, it is suitable for application to joints that need longer lifespan without fractures or stress fatigue. The top of the door-shaped anchor is designed with sharp edge, which makes it simple and easy to implant. The use of inverted hook structure with anti-receding design provides greater pullout strength. Type MX(I) of the door-shaped anchors products of the Company have cone-shaped legs while the bridge of type MX(II) of the door-shaped anchors products of the Company are made with no cone-shaped legs, which provides two types of fixation method. With the comprehensive product specifications of the door-shaped anchors products of the Company, surgeons can select according to the needs of their surgery.
